Please note that the persons holding posts with higher grade pay (pre-revised)/ higher level in the pay matrix on regular basis, should not apply for these posts.

The scale of pay of the selected officials on deputation will be regulated in terms of Department of Personnel and Training OM No.2/29/91-Estt. (Pay-II) dated 5/1/1994 as amended from time to time. If the selected officials have been granted financial upgradation/ MACP in their cadre, they will not be entitled to deputation duty allowance, but only the pay in upgraded/ MACP scale.
