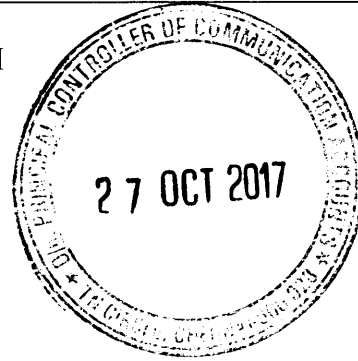



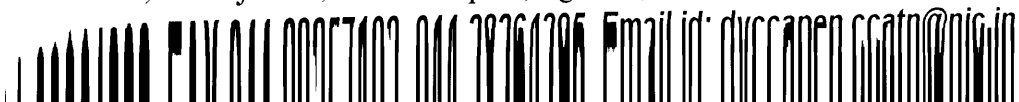

The reduced percentage of IDA Relief is applicable to cases wherein 50% merger of IDA scale of pay has been reckoned for calculation of pension and other benefits with indication in both halves of PPO and forwarding memo and in Revised Authorities as DEARNESS PAY TAKEN FOR CALCULATION OF PENSION, HENCE IDA RELIEF PAYABLE AT REDUCED RATES to this effect.

4. However for the pension payment orders issued by this office at present for IDA Pensioners, Table 'A' is applied and the rate of DA from 01-10-2017 is 124.3%. This is for your information and necessary action.
5. In respect of CDA pensioners the DA rates are furnished under table 'D' & table 'E'.
