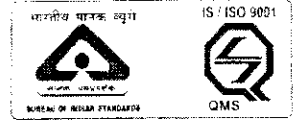

NOTIFICATION

Sub : Engagement of retired personnel on short term contract basis as Consultants in the grade of PA

The office of the PCCA, TN Circle, Chennai proposes to draw a panel of retired personnels, who had retired as Personal Assistant (PA) from Department of Telecommunications/Posts, other Services of Govt. and BSNL/MTNL for engagement on short terms contract basis as Consultant. **Preference will be given to retired officials who have worked in O/o. PCCA, TN Circle.** The panel will be operated by Head of CCA office depending upon exigencies & requirement of the office. The panel shall be valid for a period of 6 months. The terms & conditions are as under :-

- Tenure of Short-term Contract :** The retired personnel shall be appointed on short-term contract basis initially for a period of 6 months. Based on his/her performance and requirement of his/her service, the contract can be further extended up to maximum of six terms (6 months each) or 65 years of age whichever is earlier. The assessment of CCA, TNC shall be final in this regard.
- Age Limit :** Candidates should not be more than 65 years of age as on 01.06.2015.
- Computer Literacy :** Computer Literacy is necessary. Must know Short hand & Typing of a reasonably good standard.
- Remuneration for hired retired Personnel :** The consolidated fee/remuneration payable to retired persons engaged on short-term contract basis shall be retracted to the difference between last pay drawn (as per 6th CPC) by the retired official and basic pension + DA at the rate applicable for Central Government employees from time to time. The person so engaged shall not be eligible for other allowances and benefits. The payment will be made on monthly basis.
- Tax Deduction at source :** The Income Tax or any other tax liable to be deducted as per the prevailing rules will be deducted at source before effecting the payment for which the Department will issue TDS certificates. Service Tax as applicable shall be payable extra at the prevailing rates.
- Termination of contract :** The engagement of retired personnel on short-term contract basis can be terminated by either of the party with prior notice of 30 days.

The willing and eligible personnel may submit their application to the O.o. Pr.CCA, Tamilnadu Circle, 238, R.K. Nagar Telephone Exchange Building, 7th Floor, R.K. Mutt Road, Chennai 600028 in the prescribed format (Annexure-I) with supporting documents so as to reach by 03.06.2015.
